Town Speed Limit




There will be a number of visitors, possibly with children and/or dogs, over the summer holidays, so please observe the 30 kph for the safety of all concerned. This rule also applies all year.

DarkSky Community

Thank you to those people who responded with such positive comments to our initiative to become a DarkSky Community. It was heartening to see how many people appreciate the unique dark sky that we have at Port Moorwie.

We are now about to proceed with our application covering such areas as:

- Eligibility requirements ie a legal organisation officially recognised by outside groups
- **Application elements** including a map of the community showing its legal boundaries and Letters of Nomination and Support.
- **Light Management Policy (LMP)** organise a comprehensive Lighting Management Policy for all public outdoor lighting.
- **Lighting Inventory** determine if city-owned lighting presently conforms with the LMP.
- Commitment to Dark Skies Quality Outdoor Lighting including support for dark skies is shown by a wide range of community organisations.
- Sky Quality Measurement
- Education and Outreach including dark sky brochures for residents and visitors

This submission will take some time to work through and in the mean time some of our Committee will be approaching residents, landowners and visitors asking you to sign a **survey** indicating that you support our initiative. We only require minimal information and we would very much appreciate your support and that of your visitors.

No Camping in Pt Moorowie

The Yorke Peninsula Council has designated 19 bush campgrounds and a permit must be purchased before entering any of those areas. A permit covers one motor vehicle (and caravan/trailer).

Port Moorowie is <u>not</u> a bush campground.

The closest bush campground is at Mozzie Flat located 23 kilometres south of Warooka and 17 kilometres south of Yorketown - BYO water and firewood – some shade – suited to off road vehicles and camper vans only - boardwalk to sandy beach – patchy mobile phone reception – dogs to be kept under effective control – two small camping areas.

Property Checks - 2025

Defibrillator

Reminder: This has been installed on the road side of the car park adjacent to the boat ramp.

Although we hope that it never has to be used, we are realistic enough to accept that there will become an occasion for its urgent need.

Call Emergency 000 first.



Drones

Please be mindful of other people's privacy and comfort and check out the current rules before operating. Those drones weighing less than 2kg must not be flown at night or at a height/place where if any part were to fall it would land on people.

Pilots of commercial drones weighing 2kg or more need to be registered with the Civil Aviation Safety Authority (CASA) and have an operator's certificate before their UAVs (unmanned aerial vehicles) go zipping through the public airspace.



Quad/Trail Bikes

It is timely to reminder people that there are rules for the riding of quad & trail bikes — no unauthorised riding is permitted on roads and beaches in Pt Moorowie.



Practically every year we receive phone calls from concerned residents regarding the riding of quad bikes and trail bikes, particularly on McEachen Beach because of the potential damage to the sand dunes and endangerment to the vulnerable species of Hooded Plover which nest at high tide.

All motor vehicles (including quad bikes) being used on a road in South Australia requires the appropriate registration and insurance to be in effect. All roads at Port Moorowie and public beaches are gazetted as roads.

Whilst this does not come under the jurisdiction of the Friends of Port Moorowie we felt it was a timely reminder to those who perhaps don't even realise that they are breaking the law.
